

The claimed designation is a combination mark containing verbal element in Latin characters, "ASKONA" being a fanciful word and a part of the Applicant's company name; the pictorial element represents a circle, in the left part of which there is a curved line and at the top right section there is a stylized depiction of a closed eye with lowered eyelashes; the white verbal and pictorial elements are placed in the centre of a sea-green rectangle.
